#### REQUIRED DOCUMENTS/INSTRUCTIONS FOR RENUNCIATION OF PAKISTAN CITIZENSHIP

- 1. A copy of Canadian Passport along with original.
- 2. Application on form 'X' (in duplicate) with a photo pasted on right top.
- 3. Duly filled-in computer proforma to be attached with each 'X' form
- 4. CNIC/ NICOP in original with photocopies. In case of lost, police report is required.
- 5. If a person has never obtained CNIC/NICOP from NADRA, he/she has to submit the following:
  - i) An affidavit stating that he/she does not have a CNIC or NICOP with mentioning his/her complete address in Pakistan.
  - ii) A copy of birth certificate.
  - iii) Two references along with their address and contact numbers in Pakistan.
- 6. Original valid & expired Pakistani passports with photocopies. In case of lost, police report is required.
- 7. Two separate fee (i) CAD20 payable to Directorate General of Immigration & Passports and (ii) CAD160 payable to NADRA for cancellation of CNIC/NICOP.
- 8. 06 colored photographs (size 2" x  $1\frac{1}{2}$ ") with white background (two pasted on Form 'X' and four in an envelope with name & date of birth written on the backside).
- 9. Copies of NICOP/Birth Certificate/Passports of minor children mentioned on form 'X' in case of male applicant.
- 10. Copy of Nikah Nama/divorce certificate in case of female applicant provided her passport/NICOP is not modified with husband/father's name respectively.
